Translated into per-centage terms, by FY 23-24, 36 per cent of BSES's long-term arrangements will comprise pure play re-newable energy and 16 per cent, hydro power, totalling 52 per cent.

At present, around 22 per cent of long-term ar-rangements of Reliance Infrastructure led BSES comprises green power, which includes pure play renewable power of over 9 per cent (or 365 MW) and about 13 per cent (or 548 MW) hydro.

BSES' green energy com-ponent is dominated by solar power, followed by hydro, wind, hybrid and waste to energy.

Experts say that green power will help in neutral-izing cost increases.
