सुरक्षेअभावी चोर्ला घाट ठरतोय धोकादायक

गोवा, कर्नाटक आणि महाराष्ट्र या तीन राज्यांना जोडणारा तसेच निसर्गसौंदर्यासाठी प्रसिद्ध असलेला चोर्ला घाट सध्या सुरक्षेच्या गंभीर समस्यांना सामोरा जात आहे. घाटातील धोकादायक वळणांवर दिशादर्शक फलक, रिफ्लेक्टरयुक्त सुरक्षा चिन्हे, वेगमर्यादा दर्शविणारे बोर्ड तसेच आवश्यक संरक्षक व्यवस्था नसल्याने वाहनचालकांना जीव मुठीत धरून प्रवास करावा लागत आहे. विशेषतः पावसाळ्यात दाट धुके, निसरडे रस्ते आणि अवजड वाहनांची वाढती वर्दळ यामुळे घाटातील प्रवास अधिक धोकादायक बनत असून प्रशासनाच्या दुर्लक्षाबद्दल वाहनचालक, पर्यटक आणि स्थानिक नागरिकांत तीव्र नाराजी व्यक्त होत आहे.

चार्ला घाट मार्गाने दररोज शेकडो खासगी वाहने, पर्यटकांच्या गाड्या, दुचाकीस्वार तसेच मालवाहू ट्रक चोर्ला घाटातून प्रवास करतात.

घाटातील तीव्र वळणे, खोल दर्या, अचानक उतार आणि अरुंद रस्ते वाहनचालकांसाठी मोठे आव्हान ठरत आहेत. मात्र अशा संवेदनशील ठिकाणी ‘धोकादायक वळण’, ‘सावकाश क्षेत्र’, ‘यू-टर्न’, ‘ओव्हरटेकिंग बंद’, ‘धुकेप्रवण क्षेत्र’ यांसारख्या मूलभूत सूचना फलकांचाही अभाव असल्याचे दिसून येते.विशेषतः बाहेरगावाहून येणारे चालक महामार्गावरील वेग कायम ठेवून घाटात प्रवेश करतात. घाटातील अचानक येणाऱ्या वळणांचा अंदाज न

आल्याने त्यांना अचानक ब्रेक लावावे लागतात. काही ठिकाणी रस्ता अत्यंत अरुंद असल्याने समोरून येणाऱ्या वाहनांना वाट देताना चालकांची मोठी कसरत होते. अनेक भागांत मजबूत संरक्षक कठडे नसल्याने अपघात झाल्यास वाहन थेट दरीत कोसळण्याची भीती व्यक्त केली जात आहे. काही ठिकाणी कठडे बसविण्याचे काम सुरू असले तरी ते अपुरे असल्याची प्रतिक्रिया स्थानिकांकडून व्यक्त होत आहे.

पावसाळ्यात धोका अधिक वाढतो

पावसाळ्यात चोर्ला घाट दाट धुक्याने वेढला जातो. काहीवेळा काही फुटांपलीकडचेही दिसत नाही.

अशा परिस्थितीत रिफ्लेक्टरयुक्त फलक, चमकदार सुरक्षा पट्टे आणि सौरऊर्जेवर चालणारे फ्लोशिंग सिग्नल अत्यंत आवश्यक ठरतात. मात्र घाटातील अनेक भागांत अशा सुविधा उपलब्ध नसल्याने रात्रीच्या वेळी परिस्थिती अधिकच धोकादायक बनते.

काही ठिकाणी रस्त्यावरील पांढरे पट्टे पूर्णपणे अस्पष्ट झाले असून वाहनचालकांना मार्गाचा अंदाज घेणे घडवत आहोत. आज प्रत्येक शाळेत कला व संगीत शिक्षकांची आम्ही नेमणूक केली आहे. जेणेकरून आमची कलासंस्कृती भावी पिढीपर्यंत हस्तांतरित होत राहील, असे मुख्यमंत्री म्हणाले.
