Jaishankar gives Maldives India-funded water and sanitation projects

External Affairs Minister S Jaishankar on Saturday handed over to the Maldives a massive water and sanitation project worth \$ 110 million funding from India at 28 islands covering seven per cent of the population of the archipelagic nation.

Jaishankar, who is here on a three-day official visit, virtually inaugurated the projects at an event at President Mohammad Muizzu's office here and received grateful appreciation from him and Jaishankar's counterpart.

Maldives' Minister of Construction and Infrastructure Dr Abdulla Muththalib, whose ministry implemented the projects, was also present on the occasion.

"It was a pleasure to meet @DrSJaishankar today and join him in the official handover of water and sewerage projects in 28 islands of the Maldives," Muizzu

posted on X after the ceremony.

"I thank the Government of India, especially Prime Minister @narendramodi for always supporting the Maldives. Our enduring partnership continues to strengthen, bringing our nations closer through co-operation in security, development, and cultural exchange. Together, we build a brighter, more prosperous future for the region," he added.

In his speech, Muizzu acknowledged that India has always been "one of the closest" allies and "invaluable" partners, facilitating and providing aid "whenever Maldives has needed it." He highlighted that these initiatives would provide significant economic benefits, boost the local economies, and together contribute to the nation's prosperity.

Kuki students hold protest in Delhi for Kuki-Zo tribes in Manipur

Kuki-Zo groups held a protest under the banner of Kuki Students' Organisation (KSO) here on Saturday, demanding a separate administration for the Kuki-Zo tribal communities in ethnic strife-torn Manipur.

The Delhi-NCR unit of the KSO also released a memorandum addressed to Prime Minister Narendra Modi, demanding a separate Kuki-Zo administration in Manipur and opposing the Centre's decision to withdraw the Assam Rifles from the buffer zones in the northeastern state.

Around 600-800 members of the Kuki and Zo communities gathered at Jantar Mantar despite rain, KSO general secretary Seilenmang Haokip said.

"We, the Kuki Students' Organisation Delhi-NCR, write to you with a deep sense of urgency and desperation. The Kuki-Zo people are enduring severe atroc-

ities and existential threats under the current Meitei-led government in Manipur, headed by Chief Minister N Biren Singh," the organisation said in its memorandum addressed to Modi.

"The Kuki-Zo tribal communities are facing an existential threat under the current state administration, which has failed to protect our rights, our lives and our dignity," it added.

It appealed to the Prime Minister to intervene and take immediate steps to establish a separate administration for the Kuki-Zo communities in Manipur.

"We, therefore, earnestly appeal to you, Honourable Prime Minister, to intervene in this matter and take immediate steps to establish a separate administration for the Kuki-Zo tribal communities in Manipur," the memorandum read.

Two die in lightning strike in Odisha

BALASORE: At least two persons died and three others were injured in a lightning strike in Odsiha's Balasore district on Saturday, police said. The incident took place at Raipitambar village under the Soro Police Station limits when they were working on their paddy fields, an officer said. The condition of the three injured is stated to be critical and are undergoing treatment. Mobile app to mitigate human-elephant conflict launched in Assam

Assam's power department will launch an awareness drive aimed at preventing the electrocution of wild elephants through illegal power connections, Minister Nandita Garlosa said here on Saturday. This initiative is targeted at grassroots communities in Human-Elephant Conflict (HEC) hotspots, where residents sometimes resort to using illegal power connections in fences to protect themselves and their properties from wild elephant attacks.

Speaking at the inauguration of the 'HaatiApp' mobile application and a solar fence manual, Garlosa emphasised that while elephants are revered in Assam, the fear for life and property has driven some people to adopt dangerous measures.

The minister assured

that the power department would actively engage with communities in HEC-affected areas to raise awareness about the risks and legal implications of using illegal electric connections.

Garlosa expressed confidence that both the 'HaatiApp' and the handbook would significantly contribute to mitigating HEC.

Developed by the biodiversity conservation organisation Aaranyak, the 'HaatiApp' (elephant app) is designed to serve as an early warning system, alerting communities to the presence of wild elephants near human settlements.

The app also includes an ex gratia application form, allowing victims of elephant depredation to submit claims for compensation directly to the respective forest divisions, with Aaranyak assisting in the process.

The Indian Medical Association (IMA) on Saturday gave authorities a 48-hour ultimatum to complete the probe into the rape and murder of a doctor in a state-run medical college and hospital in Kolkata and warned of nationwide protests if the culprits are not arrested within the period.

The doctors' body called for an impartial, time-bound thorough investigation and also sought a detailed inquiry into the conditions "enabling the crime" along with urgent steps to improve the safety of doctors especially women in workplace.

If safety and security cannot be ensured in the citadels of learning, it only in-

dicates the incompetency of the administration, the IMA said.

The body of the post-graduate trainee doctor was found in the seminar hall of the RG Kar Medical College and Hospital on Friday.

"We demand that the authorities act with precision and in time of 48 hours failing which IMA will be constrained to initiate nationwide action.

"A fair, transparent and time-sensitive criminal investigation is in order. An ultimatum of two days is given to arrest culprits otherwise IMA will undertake nationwide protests," the IMA said in a statement.

It said that the entire medical fraternity of India is shocked beyond words at the brutal murder and that this heinous crime was committed inside the sem-

inar hall on the 3rd floor of the campus.

"There are reasons to believe that she was raped before the murder. This crime is an index of the anarchy and insecurity prevailing on the campus," it said.

"IMA HQs mourns the death of this precious daughter of India and condemns the existing situations that enabled this crime to be committed with impunity inside the campus..."

"The entire medical fraternity of India stands with the bereaved family and her colleagues," the statement said.

West Bengal Police has arrested one person in the case, a senior officer said on Saturday.

The man was an outsider who had free access to the different departments of the hospital, he said.
