

Xi will discuss 'right way forward' with Biden

The leaders will be meeting at the G-20 summit in Bali

On his first visit abroad after his unprecedented third term win, Chinese President Xi Jinping will attend the G20 leaders' summit next week in Bali where he will meet his US counterpart Joe Biden and discuss the "right way forward" to manage the differences between the two countries and avoid "miscalculation", the Foreign Ministry here said on Friday.

Xi will also attend the Asia-Pacific Economic Cooperation (APEC) summit in Bangkok, Thailand from November 17 to 19, foreign ministry spokesperson Hua Chunying said.

This will be Xi's first visit abroad after his election last month for an unprecedented third five-year term as the General Secretary of the ruling Communist Party of China (CPC) at its once-in-a-five-year Congress.

He is the first leader after party founder Mao Zedong to continue in power after completing a 10-year tenure.

According to Hua, on the sidelines of the G20 Summit in the Indonesian city of Bali and the APEC Economic Leaders' Meeting, Xi will hold bilateral talks with French President Emmanuel Macron, US President Biden, Senegalese President Macky Sall, Argentine President Alberto Fernandez, among others, upon request.

Prime Minister Narendra Modi is also attending the G20 summit. It is significant for India as it will assume the Presidency of the powerful grouping from the current chair Indonesia on December 1.

The G20 or Group of 20 is an intergovernmental

forum of the world's major developed and developing economies.

"Look, I'm not willing to make any fundamental concessions," Biden said during a post-election press conference at the White House, when asked if he would tell Xi whether the US would defend the self-ruled island from a Chinese attack.

"What I want to do with him when we talk is lay out what each of our red lines are, understand what he believes to be in the critical national interests of China, what I know to be in the critical interests in the United States, and to determine whether or not

they conflict with one another," he said. "And if they do, how to resolve it and how to work it out."

From his side, Xi will discuss establishing the "right way forward," Chinese Foreign Ministry spokesman Zhao Lijian told a media briefing here on Friday.

"China views and grows its relations with the US in accordance with the three principles of mutual respect, peaceful coexistence and win-win cooperation as proposed by President Xi, and calls for establishing the right way forward for bilateral relations," Zhao said when asked what Chinese side highlights at the talks.

Ukraine begins reclaiming Kherson

Russia relinquished its final foothold in a major city in southern Ukraine on Friday, allowing Ukrainian forces to move cautiously toward reclaiming the country's only Russian-occupied provincial capital in what would be a major morale-boosting victory.

Russia's Defence Ministry said its troops finished withdrawing from the western bank of the river that divides Ukraine's Kherson region at 5 am. The area they left included the city of Kherson, the only provincial capital Russia had captured during its nearly 9-month invasion of Ukraine.

Videos and photos circulating on social media showed local residents cheerfully taking to the streets and a Ukrainian flag flying over a monument in a central Kherson square for the first time since early March, when the city was seized by the Russians. Some footage showed crowds cheering on men in military uniform.

Imran Khan, sons get additional security cover

Imran Khan and his sons have been provided with an additional squad of commandos from the Kyber Pakhtunkhwa provincial police, days after the former Pakistan prime minister survived an assassination bid in Punjab province.

Although Khan's Pakistan Tehreek-e-Insaf (PTI) has its coalition government in

Punjab province, the party is not trusting Punjab police after the assassination attempt on his life in which he suffered bullet injuries to his right leg last week in Wazirabad area, some 150kms from Lahore.

Khan, 70, suffered bullet injuries in the right leg on November 3 when two gunmen fired a volley of bullets at him and others mounting on a container-mounted truck in the Wazirabad area

of Punjab province, where he was leading a protest march against the Shehbaz Sharif government.

He underwent surgery for bullet injuries at the Shaukat Khanum Hospital in Lahore owned by his charitable organisation.

The additional set of commandos to guard Khan and his family in Lahore belongs to the Kyber Pakhtunkhwa (KP) provincial police.

Joe Biden tightens methane emissions rule

New rule will help U.S. bring emissions down by 30%

The Biden administration on Friday ramped up efforts to reduce methane emissions, targeting the oil and gas industry for its role in global warming even as President Joe Biden has pressed energy producers for more oil drilling to lower prices at the gasoline pump.

Biden announced a supplemental rule cracking down on emissions of methane - a potent greenhouse gas that contributes significantly to global warming and packs a stronger short-term

punch than even carbon dioxide - as he attended a global climate conference in Egypt. "We're racing forward to do our part to avert the climate hell the UN secretary general so passionately warned about," Biden said, referring to comments this week by United Nations leader Antonio Guterres.

The new methane rule will help ensure that the United States meets a goal set by more than 100 nations to cut methane emissions by 30 per cent by 2030 from 2020 levels, Biden said.

"I can stand here as president... Say with confidence,

the United States of America will meet our emissions targets by 2030," he said.

The Environmental Protection Agency rule follows up on a proposal Biden announced last year at a United Nations climate summit in Scotland. The 2021 rule targets emissions from existing oil and gas wells nationwide, rather than focusing only on new wells as previous EPA regulations have done.

The new rule goes a step further and takes aim at all drilling sites, including smaller wells that now will be required to find and plug methane leaks.
