FC Goa face Mumbai City test

FC Goa will look to tighten their grip on second place in the Indian Super League (ISL) standings as they take on Mumbai City FC in a crucial encounter at the Mumbai Football Arena on Wednesday.

With a direct semi-final berth at stake, the Gaurs will be eager to break their winless streak against the Islanders and strengthen their position in the title race.

Sitting second in the table with 36 points from 19 matches, FC Goa have been one of the most consistent sides this season, winning 10 games and drawing six. However, their recent 1-3 defeat to Jamshedpur FC— their first away loss of the season—served as a wake-up call ahead of the final stretch of the league campaign. A win here would solidify their hold on second place and edge them closer to a semifinal spot, avoiding the single-legged eliminator.

Mumbai City FC, currently fifth with 31 points from 19 games, are fighting to break into the top four. A victory over FC Goa will boost their playoff hopes and extend their unbeaten streak against the Gaurs to 14 ISL matches. The Islanders have dominated this fixture, with eight wins and five draws in their last 13 encounters against Goa. If they complete a league double over their rivals, it will mark the fourth time they have done so, replicating their feats from 2017-18, 2021-22, and 2022-23.

Historically, Mumbai City hold the upper hand in head-to-head clashes,

Mumbai, Vidarbha, Gujarat make Ranji Trophy semis

Mumbai, Vidarbha, and Gujarat stormed into the Ranji Trophy semifinals with dominant performances in their respective quarterfinal clashes on Tuesday.

Mumbai outclassed Haryana by 152 runs at Eden Gardens, thanks to a sensational nine-wicket haul by Shardul Thakur (9/84). His incisive opening spell dismantled Haryana's top order in their chase of 354, while Royston Dias (5/52) played a perfect supporting role to wrap up the innings for 201. Earlier, Ajinkya Rahane's 41st First-Class century helped Mumbai post 339 despite Anuj Thakral's spirited effort (4/62). Mumbai now face Vidarbha in the semifinals.



Mumbai's Shardul Thakur was adjudged the man of the match for his all-round show against Haryana.

Vidarbha sealed their last-four spot with a commanding 198-run win over Tamil Nadu. Yash Rathod's patient 112 anchored their second-innings total of 272,

setting a 401-run target. Tamil Nadu faltered at 45/5, with Nachiket Bhute (3/19) and Harsh Dubey (3/40) leading Vidarbha's charge to bowl them out for 202.

Pradosh Ranjan Paul (53) and Sonu Yadav (57) resisted, but the deficit was too steep.

Gujarat crushed defending champions Saurashtra by an innings and 98 runs in Rajkot, securing their first semifinal berth since 2019-20. Powered by centuries from Urvil Patel and Jaymeet Patel, Gujarat posted a mammoth 511 before their bowlers skittled Saurashtra for 216 and 197. Priyajitsinh Jadeja (4/32) and Arzan Nagwaswalla (3/51) wrecked the hosts, while Cheteshwar Pujara and Sheldon Jackson endured forgettable outings in a disappointing farewell for Jackson. Mumbai take on Vidarbha, while Gujarat await their opponent as the race for the Ranji Trophy intensifies.
